BYLAW NO. 112-08

BEING A BYLAW OF CLEAR HILLS COUNTY

IN THE PROVINCE OF ALBERTA

TO DESIGNATE A PARCEL OF LAND AS MUNICIPAL RESERVE.
THE LEGAL DESCRIPTION OF THE PARCEL OF LAND TO BE DESIGNATED
AS MUNICIPAL RESERVE IS PLAN 0725747, BLOCK 1, LOT 5.

WHEREAS, the council of the Clear Hills County is authorized pursuant to Section 665 of the *Municipal Government Act*, R.S.A. 2000, c.M-26, to require that a part of a parcel of land that it owns or that it is in the process of acquiring be designated as Municipal Reserve; and

WHEREAS, a subdivision authority is authorized pursuant to Section 666(1)(a) of the *Municipal Government Act*, R.S.A. 2000, c.M-26, as amended to require the owner of a parcel of land that is the subject of a proposed subdivision to provide part of that parcel of land as Municipal Reserve; and

WHEREAS, the Council of the County has decided to designate Lot 5 of the owner's parcel of land in Clear Hills County with legal description of PLAN 0725747, BLOCK 1, LOT 5 as Municipal Reserve; and

NOW THEREFORE, THE COUNCIL OF CLEAR HILLS COUNTY, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS:


- 1. That Bylaw 110-08 is hereby rescinded.
- 2. That the County hereby designates Lot 5 of the part of parcel of land in Clear Hills County with legal description of PLAN 0725747, BLOCK 1, LOT 5 as Municipal Reserve, as shown in Schedule "A" hereto attached, pursuant to Sections 665 and 661(1)(a) of the Municipal Government Act, R.S.A. 2000, c.M-26, as amended.


CLEAR HILLS COUNTY NOTICE OF PUBLIC HEARING PROPOSED LAND-USE BYLAW NO. 112-08
