**Instructions:** This form must be completed and submitted to the Clear Hills County Returning Officer or Deputy Returning Officer prior to engaging in any campaign contributions or campaign expenses. Failure to complete and submit this form correctly will result in disqualification and could be punishable by law. If no campaign contributions or campaign expenses will be incurred, this form may be submitted with the Nomination Papers on or before Nomination Day, **September 15, 2025, at 12:00 PM.**

- **Notice of Intent:** Section 147.22 of the Local Authorities Election Act requires an individual who intends to be nominated or has been nominated to run for election in a local jurisdiction as a candidate to give written notice to the local jurisdiction before accepting a campaign contribution or incurring a campaign expense.
- **Please Note:** A notice of intent is separate from nomination forms and must be submitted for anyone intending to run as a candidate in the election. Once a candidate has submitted their notice of intent they are added to the Register of Candidates and can accept campaign contributions and incur campaign expenses. To become a nominated candidate and appear on the ballot, the candidate must complete the nomination process. **Note:** If changes are made to your notice of intent after it has been submitted, please provide a written update.
