BSE Testing Incentive Program

In 2016 Clear Hills County introduced a BSE Testing incentive program to encourage producers to participate in the BSE Testing program and assist in reaching the target of 30,000 beef cattle annually being tested to keep Canada's status as a controlled BSE risk country.

Eligibility: VSI member and resident/landowner in Clear Hills County with livestock

Restrictions: Only Veterinarian clinics (and livestock owner) will have the access to the results of the BSE test.

Process: VSI services provide a county with a list of members that had beef cattle tested in the quarterly report. County then pays the members.

\$125.00 per animal tested.



Ditching & Brushing

What is the prescribed area?

The prescribed area, formerly known as safety zone, extends 30 metres on either side of the pipeline centreline. Ground disturbance within this zone requires approval. Contact your local One-Call Centre to request a locate and TransCanada will come to the site and mark the pipeline. **The existence of the prescribed area does not necessarily mean development of the land cannot occur within the prescribed area.**

Brushing

Due to the substantial weight of brushing equipment, a crossing agreement is required before performing work on the right-of-way. Contact TransCanada to apply for an agreement.

Understanding your Land Title

The Farmers' Advocate Office (FAO) has produced a new resource for landowners who are hoping to gain a better understanding of their land title.

The document offers a visual overview of land titles, explaining language and the notations most commonly experienced by Alberta farmers and ranchers. The document, *Understanding Your Land Title*, is available online, but can also be mailed to those who prefer hard copy.

The FAO offers several key pieces of advice to landowners regarding their title:

- **Keep your address up to date.** "The address on your title is the one that will be used by energy and utility companies if they need to get in touch with you," explains Jeana Schuurman, rural engagement and communications specialist with the FAO. "Make sure your title is linked to whatever mailbox you check the most regularly."
- **Be careful when adding names on title.** "Sometimes people think that "adding another name on title" is a relatively be-

nign action, but there be unintended repercussions if the options are not well understood," warns Schuurman, "If you add a joint tenant, your actually conveying partial ownership, which means that if one party was to pass away, the other would automatically receive the estate." Registry offices will not give business advice, and the FAO suggests consulting a lawyer before making these types of changes on title.


- **Keep copies of your agreements with ener-**

gy and utility companies. "Many landowners assume that copies of their surface leases and right-of-way agreements are stored on their land titles, but they are not," explains Schuurman. "It's important to keep copies of your agreements in case problems with the site arise or the company doesn't pay its annual rental."

LAND TITLES

An Overview



A LINC is a Land Identification Number Code. This is a handy number to remember as it is permanently linked with the property rather than the owner. It is a random computer-generated number that has no meaning.

The province is divided into 3 meridians that run longitudinally. Ranges also run vertically, and they are between the meridians.

Townships run horizontally, starting at the US Border with at 1. A township contains 36 sections, and they are ordered starting in the southeast corner.

Your short legal land description is always abbreviated on title in the following order: Meridian, Range, Township, Section, Quarter. Be careful because people will not always use this order when communicating in ordinary life!

The Torrens system of dividing land is very organized, but not all properties are perfectly square. The "excepting thereouts" on your property may follow topographical features, in which case it would be described in metes and bounds. Although this was done historically, land is no longer subdivided this way.

There may be "excepting thereouts" for road use plans. If you are interested in seeing the road use plan, these can be found on SPIN under Registered Documents.

Road use plans can sometimes help identify the origin of certain public infrastructure that is not listed elsewhere on title (ditches, bridges, etc.)

Fee simple is the highest form of land ownership in Canada. It means you have absolute tenure over the land and ability to dispose of it freely.

It is so important to keep your address on title up to date! This is the address oil and gas companies will use if they are trying to get in touch with you.

The majority of Albertan landowners do not own the subsurface rights to their land and will therefore see the words "Excepting Thereout All Mines and Minerals" beneath each quarter.

If you are thinking of "adding a name on title," it is important to understand the full repercussions of that decision. A joint tenant means you are transferring partial ownership to another person. In the event of death, a joint tenant will automatically receive the estate. In contrast, if a tenant-in-common dies, their share goes towards their heirs, not the surviving tenants.

"Caveat" is a Latin word meaning "let him beware." On title, a caveat provides a warning that the caveator claims in interest in that parcel of land. Caveats can only lapse, or be withdrawn or discharged. Only one caveat can be registered for each surface lease, so you'll never see two caveats registered for the same development.

A lease is a contract that provides a lessee to exclusive possession of the property for a defined term. The lessor's interest is considered "fee simple estate in reversion" because it can revert back to the grantor at the end of the lease term.

Copies of surface leases or amendments to surface leases are not registered on title, so it is important to maintain your personal records. If the company was to become insolvent, the application to the Surface Rights Board is simpler with a copy of the surface lease.

A restrictive covenant refers to an agreement to use the land in a certain manner. These are negative in nature (i.e. you cannot do X) to ensure there is a mechanism for enforcement.

A restrictive covenant always has a party that restricts behaviour and a party that benefits from that restricted behaviour. This caveat will affect subsequent owners of the land, but it cannot be discharged in the same way as a typical caveat. Landowners should be aware that restrictive covenants from the municipality can only be discharged through the municipality or the courts.

An easement confers on the owner of a parcel of land "the right to use the land of another in some way, or to prevent it from being used for certain purposes."

A blanket easement may cover the entire parcel, not just the location of the infrastructure. In agriculture, easements are most commonly used for roads and utilities.

Safety Winter Burning Practices

The 2016 Fire Season ended October 31, 2016. Although you no longer require a fire permit for burning within the Forest Protection Area, once you light a fire, you are responsible if a wildfire results from the burn. Take the time to properly prepare your burn site, know the requirements you need to be successful during your burn and know how to extinguish your site.

- Have someone on site monitoring the burn the entire time—if it escapes, immediately report it to

310-FIRE.

- Only burn what you can control with the equipment and people you have available and always burn according to weather conditions.
- Always ensure proper safety precautions are taken when burning and appropriate signage is in place when burning within a mile of a roadway. Always take safety concerns that may arise from the smoke your burning creates into considerations.

After you burn:

- Spread out the remaining material within the pile.
- Soak the area and ensure both heat and smoke are no longer being produced by the pile—it should be cool to the touch.
- Check your burn site multiple times in the coming weeks to ensure it has not reignited.

Safe burning practices are always in season—don't let your winter burn come back to life in the spring.

Area Wildfire Update

There have been 136 wildfires in the Peace River Forest Area this fire season with a total of 328.55 hectares burned.

Peace River Forest Area staff also assisted on 9 mutual aid wildfires with a total of 309.26 hectares burned and a large wildfire that started in British Columbia that remains under control with 22,838.60 hectares burned on the

Alberta side border.

Of the eighty human-caused wildfires in the area this season, many were the result of fires that were not properly extinguished during the winter. When the conditions became favorable in the spring, they reignited and became wildfires.

Bill 36 *An Act to Enhance Off-Highway Vehicle Safety*

On December 6, 2016 Bill 36 *An Act to Enhance Off-Highway Vehicle Safety*, passed third reading in the Alberta Legislature with a wide support from all parties. The bill will make helmets a requirement for OHV use on public land in Alberta.

As you may recall, the Government of Alberta conducted a survey in September 2016 to understand how Albertans felt about off-highway vehicle (OHV) helmet use. With more than 65 per cent of respondents supporting helmet requirements for all OHV users on public land, legislation was drafted to support that positions.

Though the Government of Alberta recommends that anyone operating an OHV wear a helmet, doing so will not be a requirement on private property. Farm and ranch workers will continue to be exempt from this requirement, as per Occupational Health and Safety Laws. Exemptions were also put in place for First Nations lands and Metis Settlement Lands. Regulations will align helmet safety standards with CSA/DOT standards, set fine amounts for those not complying with the helmet requirement and determine any further exemptions. These regulations will go into effect at the same time as the helmet law, expected in May 2017.


Driveway Snowplowing Program

The Classroom Agriculture Program (CAP) is in need of volunteers!

Orange Hawkweed

Hieracium aurantiacum
Alberta Regulation:
 Weed Act


Overview:

Orange hawkweed is a member of the Aster Family native to Europe. It is a fibrous rooted, perennial herb with a milky latex in the stems and leaves. Hawkweeds reproduce by seeds and vegetatively by numerous horizontal stolons, and rhizomes underground.² Seeds are produced by apomixis - asexually - as non-native hawkweeds are polyploids ($n=9$), as opposed to the native diploid hawkweeds.¹ Occasional sexual reproduction occurs.¹

Hawkweeds develop a low rosette of basal leaves before producing a flowering stem. Dandelion-like flowers are borne at the ends of stems. Orange hawkweed is unique among both native and introduced hawkweeds in that flowers are a fiery orange colour. All other hawkweed are yellow flowered and there is one white flowered species.

Non-native hawkweeds exhibit many characteristics of an invasive plant: high seed production and germination rates, asexual seed production, wind-dispersed seed, vegetative reproduction via rhizomes, stolons, and root fragments, and rapid growth.¹ A

few invasive hawkweed species are popular ornamentals. All of these characteristics facilitate rapid colonization and monopolizing of resources. An undetected patch of hawkweed has great potential to become an un-eradicable infestation.

Habitat:

Hawkweeds prefer well drained, coarse textured soils, moderately low in organic matter, in mesic habitats.¹ It can successfully grow under coniferous forest canopy.

Identification:

Stems: Are erect, usually solitary, and leafless or with leaves or with just 1 or 2 greatly reduced leaves.² Stems bear numerous stellate, glandular, and simple hairs. Plants grow 10-60 cm.¹ Stolons are present and hairy.²

Leaves: Basal leaves are oblong/lance-shaped to elliptic, and narrow to a petiole, and 4-20 cm long 1-3.5 cm wide. The upper leaf surfaces bear numerous simple hairs and the lower surfaces bear both simple and

stellate hairs. Leaf margins may be entire or slightly toothed.²

Flowers: Red-orange ray flowers are borne in open, rounded clusters of 20-50.¹ Involucral bracts are lance-shaped, 5-8 mm tall², with numerous stellate, blackish glandular, and simple hairs.¹ Achenes are narrowed at the base, 1.5-2 mm long, with a brownish pappus.²

Prevention:

Learning to recognize hawkweeds from the many yellow-flowered members of the Aster Family is key to prevention. Hairs are an important characteristic of non-native hawkweeds and also in distinguishing between species. Stolons facilitate rapid colonization of a patch of ground. Long term management of hawkweeds requires maintaining healthy forbs and grasses - fertilization of desirable vegetation can result in out-competition of hawkweeds. Re-seed disturbance in areas susceptible to hawkweed invasion.

Orange Hawkweed (Continued)

Grazing: Unknown. Invasive plants should never be considered as forage.

Mechanical: Mowing before flowering will prevent seed production of taller plants but will not inhibit reproduction via stolons and rhizomes. Hand digging of small infestations where all stolons and root can be removed may be effective. Root fragments can generate new plants, therefore any mechanical tilling/cultivation would be ineffective.

Chemical: Hexazinone, 2,4-D, and glyphosate are registered for use on *Hieracium* spp./hawkweeds. Always check product labels to ensure the herbicide is registered for use on the target plant in Canada by the Pesticide Management Regulatory Agency. Consult your local Agricultural Fieldman or Certified Pesticide Dispenser for more information.

Biological: The stolon-tip gall wasp *Aulacidea subterminalis* was first released in BC in 2011. Results are pending.³
