ASB Grant Program Review Engagement - "Stand Out's"

 The points that follow are by no means a comprehensive or definitive response to what surfaced in the Program Review. What follows is simply what stood out to the Consultant-Facilitator and the Project Team (Core Group).

Program Impact - Achieving the ASB Grant Program Purpose

- From the standpoint of ASB Grant Program mandate and operations, stakeholder feedback indicates that the Program functions well. As expected, there are opportunities to improve the Program in select areas.
- It is challenging to assess Program impact in the absence of defined, quantifiable success indicators or outcome measures, i.e. strategic level. Program evaluation experience is needed to identify appropriate impact/outcome measures for the Province (and potentially for ASBs).
- Longer-term economic impact assessment of the ASB Program would go a long way to demonstrate credibility and viability.

"Telling Our Story",

- There was considerable interest in this topic, especially around the ASB Program economic impact, the value proposition in ASB programming. Credible data, relevant measures are important in telling the story.
- Communication, advocacy, and education were seen as essential to getting the story out to Albertans rural and urban population, youth of all ages.

ASB Grant Program - Moving Forward,

- It is important the Program remains flexible, accommodates both provincial and distinct local or regional concerns.
- A variety of bold, emerging or new ideas came forward for ASB Grant Program funding.

Strengthening AF \leftrightarrow ASB Working Relationship,

- Many practical ideas were raised for how to better understand or utilize the Key Contact Program. There is concern about a dwindling AF presence in rural Alberta, i.e. succession plans for AF staff including Key Contacts.
- Communication and the working relationship are generally good and hinge on trust and 2-way communication.

Ag-Fieldmen and ASB Member Common Concerns,

- The data analysis revealed common thinking between the two target audiences, most notably around outcome and operational measures, "telling our story", desire for flexibility in the Program (accommodate regional differences), support for the Key Contact Program, concern with timeliness in the resolution process, and the need to better identify, track and communicate results/outcomes of the resolution process, i.e. changes to programming, practices, legislation, policy.
- Government of Alberta Ministries and other agencies that have a role with the ASB-governed legislation and compliance need to better integrate, align requirements and support of ASBs and municipalities.

Resolution Process,

- ASB Members want to more fully understand how the resolution process works and the outcomes change in policy, operations, practices. A number of practical ideas surfaced for streamlining or improving the resolution process.
- The purpose of resolutions beyond input to policy development caught the attention of ASB members, i.e. Resolutions *inform* the AF and other relevant agencies about issues/concerns that ASBs view as important.
- Both stakeholder groups are concerned with the timeliness of the resolution process, especially around reporting back standings and outcomes. Striving for high quality and prioritized resolutions is a concern.

Regional Differences,

- South
 - Invasive species (e.g. Knapweed) are a big concern.

Central

- Concerned about two-way communication between AF and ASBs.
- Had ideas around Ag-Fieldmen "resource officers", farm safety insurance packages, and Sustainable Certified Farms.
- The spread of Clubroot is an issue.

Northwest

- Concerned with government downloading, the loss of AF extension services (District Agriculturists and District Home Economists, other local and regional Specialists).
- Introduced the concept of a "Centre of Excellence for Agriculture". Region with the most concerns about urban sprawl and the loss of agricultural land.
- Raised points on a Resolution banking system (i.e. inventory), ASB economic impacts, Seed Cleaning Plant upgrades, and mounting weed issues on abandoned oil field reclamation sites.

Peace

- More access to Key Contacts. Feel isolated and disconnected.
- Concerned about the effects of the global market on the region.

"We Have Common Diverse Problems within the Regions",

ASB Members appreciated the opportunity to mix with other ASBs in their region, hear and understand both common and distinct issues. Ag-Fieldmen expressed the same view.

Feedback & Evaluation - Indicators of Engagement Success

- ✓ Target response rates for both the Ag-Fieldmen Survey and the ASB Member participation in the Face-to-Face Sessions were met: 80% survey response rate; minimum of 20 ASB Member participants registered.
- ✓ Overview Report to ASB Member Face-to-Face Session participants and continuous communication with the target stakeholders through the duration of the Grant Program Review, supported awareness of the process and a feedback loop.
- ✓ "Return on Investment for This Session" evaluations were overwhelmingly positive. For example:

"I was glad to be included in this process and to be able to be heard and have input to the direction of the ASB."

"(I) appreciated the process and the ability to hear from board members on what's good and what could be better."

"All worked very well - a wealth of information."

"Such sessions should be mandated every 5 years minimum."

Participants frequently expressed their appreciation for mixing ASB representation through the day and with different topics. They were very pleased with the opportunity to hear the concerns and interests of other municipalities in their region, both common ground and unique perspectives. There was obvious comfort in the realization that many ASBs share the same concerns.

Rhizophagy-

- Powerful root enzymes dissolve bacterial membranes
- Plants eat nutrients
- Membrane less bacteria spit back out into the soil
- Reform membrane

Power of Mycorrhizal Fungi -

- Far better than plant roots at picking up nutrients in the soil (6-10xs)
- Solubilize bound nutrients (especially P)

- The Mycorrhizal system extends 40-60 cms beyond the plant roots themselves
- Mycorrhizal fungi increase the absorptive surface area of plant roots hundreds to thousands of time

- o Herbivores will eat 30-60 different foods daily if given the opportunity. A lot of some, a little of others; changes during different seasons

The Board is presented with information from regarding Cleanfarms being selected as the program operator for ag plastics collection and recycling.

BACKGROUND:

Agricultural Plastics Recycling Group (APRG) through Alberta Beef Producers (ABP) have selected Cleanfarms as the program operator for a three-year pilot program to collect agricultural grain bags and twine for recycling. Cleanfarms is looking for 20 sites across the province to become collection sites.

The Agricultural Plastics Recycling Group and Alberta Beef Producers have selected Cleanfarms to operate a three-year pilot program in the province to collect agricultural grain bags and twine for recycling.

The first phase of the project is to establish up to 20 collection sites across the province that are intended to be operational by fall 2019.

Information Sessions Last Week of June

Cleanfarms will host two in-person information sessions with interested organizations in the last week of June to discuss the program in more detail. Watch for more information in the next few weeks.

Cleanfarms will be in touch with those who registered to discuss required criteria.

Typical Requirements

Typical requirements for a site may include but aren't limited to:

- Location (project requires up to 20 sites covering all major regions of the province)
- · Accessibility for a 53-foot semi
- All-season suitability
- Loading capabilities (i.e., loading dock and forklift, grappler, etc.)
- Fencing
- Vector control

Cleanfarms will provide communications and educational support for the program.





Cleanfarms Posts Increases in 2018 Ag-Plastic Recovery Programs

Cleanfarms continues to demonstrate that Canada's agricultural community is committed to managing farm waste responsibly.

In its <u>2018 annual report</u> just released, Cleanfarms recorded an increase in recovery of its Canada-wide empty small plastic container collection program of 14% by volume over 2017. In total, farmers brought back nearly 5.8 million empty containers (23L and under) for recycling into new products such as farm drainage tile.

Cleanfarms is a national non-profit industry stewardship organization that is funded by the Canadian crop protection, fertilizer, seed and agricultural plastics industries. The collection and recycling of empty agricultural pesticide and fertilizer containers is the best known and longest running of its ag-waste recovery programs. Overall, Cleanfarms' mandate is to contribute



to a healthier environment by recovering agricultural and related industry plastics, packaging and products for recycling or safe disposal.

"Despite the challenges of shrinking overseas markets for recycled commodities, Cleanfarms continued to meet its goal of sending all materials collected for recycling to end markets to be remanufactured into new products. This is a prime example of the circular economy at work in the agricultural community," said Cleanfarms General Manager Barry Friesen.

Other Cleanfarms programs also posted increases in recovery. The collection of empty agricultural seed, pesticide and fertilizer bags in Eastern Canada climbed by 22% by volume over 2017. The largest increase occurred in Quebec where recovery numbers jumped to nearly 194,000 kg from about 110,000 kg in 2017.

Fueled by the success of this program in Eastern Canada, Cleanfarms is pilot testing the collection of seed, pesticide and fertilizer bags in Manitoba, Saskatchewan and Alberta in 2019. Empty bags are recovered for proper disposal instead of being buried in landfill sites.

At the core of Cleanfarms' commitment to help farmers manage agriculture packaging and products responsibly is its unwanted pesticides and livestock medications collection program. Operated in partnership with the Canadian Animal Health Institute, the program provides an essential service to farmers allowing them to take old, obsolete and unwanted pesticides and livestock/equine medications to Cleanfarms drop-off locations. These materials are transported by a licensed waste hauler to specialized facilities where they are disposed of safely. The program rotates to all regions of Canada every three years. In 2018, 74 ag-retail partners in Nova Scotia, New Brunswick, Northern Saskatchewan, Southern Alberta and British Columbia collected for safe disposal a total of about 181,000 kg of unwanted commercial pesticides and nearly 2,500 kg of unwanted and obsolete livestock/equine medications.

2018 also marked the first year of the provincially-regulated grain bag recycling program in Saskatchewan. Though this program is just getting underway, it has already collected nearly 1,260 tonnes of grain bag plastic for recycling. The primary use for this recovered material is in the manufacture of garbage bags.

"Thanks to our industry members, Cleanfarms operates in the Canadian agricultural community as an important partner in helping farmers manage their farm operations responsibly and sustainably. That's what drives us to develop and expand programs that offer continuous improvement in access and convenience," Friesen said.

We have had an extremely positive response from municipalities across the province who want to participate in this program. The project budget will support up to 20 collection sites across the province for the first year of the pilot.

The next step will be to engage those groups to determine the site locations with the goal to start material collection by early Fall.
