





North Peace Housing Foundation Board Meeting Synopsis July 3, 2019

Energy Efficiency

On June 11, 2019, North Peace Housing met with Dean Tithecott, Field Coordinator with Energy Efficiency Alberta's delivery partner, Ecofitt, to discuss the size of our portfolio and the proposed implementation plan for the fall of 2019. Ecofitt's team hopes to be back in Peace River in late August or early September to get started with the changeover to more energy efficient lighting, faucet aerators, low-flow shower heads, pre-rinse spray valves, smart power strips, smart thermostats and outdoor outlet timers.

Telecom Savings

North Peace Housing Foundation is currently working with Costek, telecom industry professionals and cost reduction specialists, to review our current telecom expenses to determine if we are eligible to take part in their cost savings program. Costek is a complete telecom consulting service program that is designed to help organizations reduce telecom costs and optimize services; they boast a 30%-50% savings.

There is zero risk to the Foundation with no upfront fees, as Costek only gets paid when we save; they have extensive telecom cost reduction services that include internet, telephone, mobility, Wi-Fi, etc.; Costek will help the Foundation find the most savings possible, as they have designed a variety of pricing models, strategies and service innovations for leading telecom carriers; and, because they have no vender preferences, we will not be required to change our current vendors.

Additionally, we discussed our need to upgrade our existing mobility devices with our Costek representative, who felt confident that he would be able to offer us substantial savings. We hope to receive a service proposal in the upcoming weeks.

Del Air Lodge Evacuation, Manning

Now that all emergency alerts have been lifted for the Manning area, I am working with the Manning and Fairview/Hines Creek Managers to plan an appreciation event for staff and volunteers who helped with the Manning evacuation.

Board of Directors' Meeting Minutes Page 2 February 6, 2019

At present, there is no information regarding the evacuation debriefing that was discussed at the June Board meeting; we will be investigating further to see if North Peace Housing will be included in the session, as we feel that it will be an invaluable learning opportunity.

Practicum Student

The North Peace Housing Foundation had the pleasure of having a student from the Northern Lakes College Social Work program complete her first practicum at Central Office. Our Community Housing Accommodations Manager spent a great deal of time and effort organizing and scheduling opportunities to not only become familiar with the programs offered by the Foundation, but also programs and services provided by outside community agencies that we regularly come into contact with. She had the opportunity to visit and interview seniors in our Lodges, work with the Recreation department, assist FCSS in hosting a senior's event, interview potential tenants, assist in Annual Income Reviews, assist in unit inspections, visit the Employment and Immigration office and had the chance to help out at the evacuation centre. The Foundation wanted to ensure that the experience was fulfilling and educational and I believe that through combined efforts, we succeeded.

Resident and Tenant Levels

As of May 31, 2019, we had a total of 189 lodge residents, consistent with the month of April. Our lodge unit occupancy currently equates to 84% occupied of the 224 lodge suites.

We had 122 occupied senior apartment suites at the end of April, which is the same occupancy as March; this equates to a 94% occupancy rate.

Garden Court Seniors Apartments had 57 out of 63 units occupied at the end of May, which is up 1 tenant from the month of April. We continue to have 6 out of the 8 trailers in Cadotte occupied, with no pending applications.

The Family Housing units had 79 of the 123 Community Housing units occupied, down 1 from the month of April, and 23 of the 40 R&N units occupied, with an overall occupancy of 63%.

Rent Supplement tenancies decreased by 1 for the month of March; we are currently at our maximum capacity as determined by our Rent Supplement budget and the total amount of monthly subsidies that are being allocated at this time.

IT & Communications

The staff training focusing on awareness of issues around aging, which arose out items brought up in our tenant meetings, has been completed. Training was held in Fairview, Hines Creek, Manning and Peace River and was well attended by managers and staff. A new round of training on improving staff knowledge of the various services provided by the Foundation is being readied for the fall.

The summer internal newsletters, The NPHF Times for residents and tenants and the Foundation newsletter are in late stage progress and will be released shortly.

The transition to Office 365 is progressing as planned and the Lodge Managers are scheduled to have the transition completed by mid-month. This will improve both data security and intrafoundation communication ability.

We have had favourable response to our Garden Court air-conditioner windows insert program with several tenants taking advantage of the program.

Regular Agenda Items:

The Board has approved the delivery of training by MNP for Board Members on understanding financial information and the also including the development of improved financial communication formats for ourselves and our stakeholders.

As part of the Foundation's ongoing review of governance, the Board approved an updated Role of Board Members which clarified the role of the Board Chair as the only person authorized to speak on behalf of the Board while encouraging individual Board Members to advocate for approved Foundation goals and policies.

The Board ratified Tammy Menssa as Executive Director of the North Peace Housing Foundation. Ms. Menssa joined the Foundation in the fall of 2010 as the Housing Facilities Manager at the Autumn Lodge in Berwyn and, since that time, has held several positions of increasing responsibility.

BYLAW NO. 242-19

A BYLAW OF CLEAR HILLS COUNTY IN THE PROVINCE OF ALBERTA, FOR THE PREVENTION OF FIRES AND THE PRESERVATION OF LIFE AND PROPERTY FROM INJURY OR DESTRUCTION BY FIRE.

WHEREAS, Sections 7 and 8 of the *Municipal Government Act of Alberta, 2000 being Chapter M-26.1* authorizes the County to pass bylaws that regulate or prohibit the burning of fires for the safety, health and welfare of people and the protection of people and property; and

WHEREAS, the Forest and Prairie Protection Act, R.S.A. 2000 Chapter F-19 grants certain additional powers and responsibilities to Clear Hills County and pursuant to Sections 7 and 8 of the Municipal Government Act, Council may pass bylaws for the prevention of prairie or running fires and the enforcement of the provisions of the Forest and Prairie Protection Act in that behalf; and

WHEREAS, the Council of Clear Hills County considers it desirable to provide for the prevention, regulation and control of the lighting of fires within Clear Hills County and for the preservation of life and property from damage or destruction by fire on the terms hereinafter provided:

NOW THEREFORE, the Council of Clear Hills County, in the Province of Alberta, duly assembled, enacts as follows:

DEFINITIONS:

The following definitions will apply to this bylaw:

- a) COUNCIL shall mean the Council of Clear Hills County.
- b) CHIEF ADMINISTRATIVE OFFICER shall mean the Chief Administrative Officer of Clear Hills County, in the Province of Alberta.
- c) COUNTY shall mean Clear Hills County.
- d) FIRE means a process or state of combustion where a flame may or may not be produced.
- e) FIRE BAN shall mean a provincial ministerial order or the enactment of a ban on open fires or other fires deemed to be hazardous in the County in
- f) FIRE CONTROL ZONE refers to the corresponding numbered Fire Control Zone established in the Fire Control Regulation (Alberta Regulation 29/2005). Fire Control Zone 32 is the Forest Protection Area in Clear Hills County.
- g) FOREST PROTECTION AREA means an area, or the area designated under section 41 (c) of the *Forest and Prairie Protection Act*.
- h) NON-PERMIT AREA means an area of land that is not within the Forest Protection Area and that has been designated as a non-permit area by Ministerial Order.
- i) OHV means off-highway vehicle, and has the same meaning assigned to it in the *Traffic Safety Act.*

Section 1: FIRE BANS

- 1. Clear Hills County Chief Administrative Officer or designate will issue a Clear Hills County Fire Ban at such times as the Minister issues a Fire Control Order for Fire Control Zone 32, pursuant to the *Forest and Prairie Protection Act*, see map in Schedule A.
- 2. A Clear Hills County Fire Ban will:
 - REQUIRE all outdoor fires presently burning in the Non-Permit Area of Clear Hills County to be extinguished; and
 - b. PROHIBIT the lighting of outdoor fires in the Non-Permit Area of Clear Hills County.
- 3. Without limiting section 2, a Clear Hills County Fire Ban expressly prohibits the use of each of the following:
 - a. Wood fires in the backcountry
 - b. Wood fires in random camping areas;
 - c. Wood fires in engineered facilities in campgrounds;
 - d. Wood fires on residential properties;
 - e. Fires using charcoal briquettes;
 - f. Turkey fryers; and
 - a. Tiki torches.
- 4. Pursuant to section 8 of the *Forest and Prairie Protection Regulation* A Clear Hills County Fire Ban will expressly prohibit the use of:
 - a. Fireworks; and
 - b. Exploding targets.

The Fire Ban will also revoke any written permission permitting the use of fireworks that had been granted prior to the Ban coming into effect.

- 5. Clear Hills County Fire Bans do not apply to:
 - a. Portable propane fire pits, that are CSA approved or UL certified, within campgrounds, backcountry area, random camping areas and on private land;
 - Gas or propane stoves and barbeques, that are CSA approved or UL certified and are designed for cooking or heating, within campgrounds, backcountry areas, random camping areas and on private land;
 - c. Catalytic or infrared style heaters within campgrounds, backcountry areas, random camping areas and on private land; and

Section 2: OFFENCES

 Any person who ignites or allows to burn a fire while a Fire Ban is in effect may be found in violation of this Bylaw.

- 2. Any person who contravenes a provision of the Bylaw is guilty of an offence and is liable to a penalty as set out in attached Schedule B.
- Any single contravention of this Bylaw shall be considered as a single offence and shall not limit additional penalties of this Bylaw from being enforced for additional offences.
- 4. Nothing in this bylaw shall be construed as curtailing or abridging the right of the County to obtain compensation or to maintain an action for loss of or damage to property from or against the person or persons responsible.

Section 3: VIOLATION TICKETS

- 1. The Chief Administrative Officer or a County authorized enforcement officer is authorized and empowered to issue a Violation Ticket pursuant to Part II of the *Provincial Offences Procedure Act.*
- 2. A Violation Ticket shall be issued for each single offence of this Bylaw as per Section 3. 3 of this Bylaw.

Section 5: SEVERABILITY

1. Should any section or part of this bylaw be found to have been improperly enacted, for any reason, then such section or part shall be regarded as severable from the rest of this bylaw and this bylaw remaining after such severance shall be effective and enforceable as if the section found to be improperly enacted had not been enacted as part of this bylaw.





Re: Canfor Hines Creek Trail – Alternate Route in the Private Land Area Request

As the Club has received or is aware of the support of all land owners and stakeholders directly impacted by the proposed alternate route in the private land area of the Canfor Hines Creek Trail, the purpose of this letter which is being issued in conjunction with the Detailed Proposal is to formally request the approval of the County for the route and assistance with a development item associated with the trail. As in the past, once the approval of the primary stakeholders (Clear Hills County, Village of Hines Creek and Alberta Environment and Parks) is in place, Licence Agreements will be finalized with land owners along with formal agreements required by other stakeholders, prior to development work being initiated. The plan is to carry out development work once harvest is finished and/or there is sufficient frost so that a fully operational trail is in place for this coming winter.

This alternate route directly impacts the County of Clear Hills as follows:

- The trail utilizes additional portions of undeveloped road allowance RR43 to the south of the portion utilized by the existing trail. Vegetation removal will be required and the Club plans to do so utilizing a mulcher followed by a slashing crew.
- The existing trail utilized a field to the side of undeveloped road allowance RR43 for a ½ mile and as the land owner is no longer willing to grant access, this portion of undeveloped road allowance RR43 will also be utilized and will require vegetation removal as well.
- Two (2) new County road crossings will be required. These crossings will replace two crossings on the existing trail that will no longer be utilized. The existing County installed road crossing signs on RR44 would require relocation to a point approximately 1 ½ miles to the south and the signs on TR842 would require relocation to a point approximately a ½ mile to the east. The Club is requesting the assistance of the County in removing and re-installing these signs.

Please refer to the Detailed Proposal and the rough map attached to for clarification of the above. All other details associated with the original development of the Hines Creek Trail will remain unchanged.

As the Club had anticipated that the identification of an alternate route would involve an extended timeline, we are very pleased to be able to bring forward a proposed alternate much sooner. It must be highlighted that this is only possible due to the diligence of Jamey Bettenson in identifying a potential crossing for Highway 64, the Village of Hines Creek for being open to considering the use of the access and area to the south of their sewage lagoon, and the resident land owners for giving consideration for the trail crossing their property when others had denied such access. We do hope that Council will find the route proposed to be such that they can grant their approval. If requested, arrangements can be made to have a member of the Club attend the Council meeting where this item will be discussed.

Detailed Proposal

Alternate Route on Private Land Portion of the Canfor Hines Creek Trail

Organization Name, Status and Objectives

The Peace Valley Snow Riders Association (the Club) was organized in October 2009 and hence the Club will be celebrating their 10th anniversary this fall. The Club was incorporated under the Alberta Societies Act in July 2010 and has been a member of the Alberta Snowmobile Association (ASA) since inception. Current annual membership is 112, the highest in Club history.

The Club has developed four (4) trails (Osmond/Getaway Cabins Leddy Lake Trail, Baytex Wesley Creek Trail, Smith Mills Trail and Canfor Hines Creek Trail) totalling approx. 185 kilometers. In addition to the regular maintenance of vegetation and signage, the Club has continued to upgrade the trails. One of the more recent examples it that rest areas now exist on all trails with outhouses and wood sheds being added to the existing picnic tables and fire pits. In addition to the Club's Arctic Cat groomer, Allard Logging Ltd. has donated labour and equipment to carry out the majority of the grooming services. All trails were groomed at least once this past winter except where access was limited.

You will note that the Hines Creek Trail has been renamed to the <u>Canfor</u> Hines Creek Trail. On May 22, 2019, Canadian Forest Products Ltd. signed a five year Sponsorship Agreement with the Club and hence the Club will be providing promotional services in return.

The Club's purpose in operating local trails is to be "Part of the Solution" by promoting responsible snowmobiling and in particular, directing snowmobile traffic to areas of acceptable use.

Objectives and Classification of Trail

As this proposal covers a change to the Canfor Hines Creek Trail, the objectives and classification remain the same as the approved Expression of Interest and Detailed Proposal previously approved. An alternative to a portion of the route in the private land area is being brought forward for approval as the result of Manulife denying access after purchasing a significant portion of the land associated with the initial route on private land.

The alternate route proposed allows for the staging area to remain in the Village of Hines Creek thus fulfilling the Club's intent to have a trail that provides services to snowmobilers and as a

result benefits the Village economically due to the access to food, shelter, fuel and the existing snowmobile dealership. Unfortunately this alternative does not directly connect to the bed & breakfast located outside the Village however the trail can be accessed by approximately one mile of travel on County roads. As previously proposed, the trail will be developed for snowmobile use to the standard 5 metre width although it may be narrower in areas to minimize impact to merchantable timber but in no case will the trail be narrower than 3 metres.

Of the original 13 km portion of the trail in the private land area between the Village and kilometer 5 of the Canfor P-100 road, approximately 5.5 kilometers will continue to be part of the alternate route. The total distance travelled will remain the same although the trail will now require a crossing on Highway 64 in place of the previous travel under the Jack Creek Bridge.

Proposed Improvements and Level of Development

The majority of the trail will run on the uncultivated edge of land that is agricultural production which will require only minor removal of vegetation. This work will be carried out manually by volunteers. A mulcher followed by volunteer slashers will be required to clear vegetation on portions of the undeveloped road allowance that runs parallel to the Canfor P-100 road as well as on the south side of the Village of Hines Creek sewage lagoon. The Club's signage and markers removed from the original route would be re-installed along the proposed alternate route with additional materials sourced by the Club if required. A request will be made to the County of Clear Hills to relocate current signage associated with two County road crossings to the location of the two new crossings. The Club will work with Alberta Transportation in regards to the requirements associated with the crossing of Highway 64.

Resources & Funding Available for Trail Life Cycle

Development Funding

Considering the Club started last winter with less than \$600 in their bank account, the Club is in a very good financial position to fund this project and hence will not need to seek funds from other sources. At June 30, 2019 the Club had \$16,463.09 in their bank account thanks in part to a one time donation of \$5,000 from Mercer Peace River Pulp Ltd. earlier this year and the recently received first annual sponsorship payment of \$3,500 from Canadian Forest Products Ltd. As there was \$1,089.27 of designated funds left over at the end of the original development of the Hines Creek Trail for which donor support was received to transfer to operations, these funds will be specifically requested to be redirected to the development of

this alternate route. A motion to approve the funds for the development of this alternate route will be presented to the Club's Annual General Meeting in October with work to take place following as soon as harvest has been completed and/or there is sufficient frost to do so.

On-going Trail Maintenance/Operations

As previously noted, Canadian Forest Products Ltd. has signed a Sponsorship Agreement with the Club in regards to this trail for \$3,500/year for the next five years with the primary intent being that these funds be utilized for maintenance of the trail. It is intended that Club volunteers carry out as much of the maintenance as possible however contracted services such as slashing crews and mulchers will be hired when the magnitude of the work requires. Other financial resources of the Club will also be redirected when required.

<u>Map</u>

A marked up map titled "HC Private Land Alternative #2A pink & blue" showing the proposed alternate route has been attached. The existing route is shown in black with proposed route highlighted in pink and blue. The blue section Option B has been selected for the route. As the map does not provide any detail, following in a description of the alternate route starting at the staging area located in the Village and ending at kilometer 5 of the Canfor P-100 road:

Section 5

- The trail leaving the staging area within the Village remains unchanged until it reaches Highway 64.
- At Highway 64, the trail utilizes two aligned road approaches to cross the highway. Alberta Transportation has indicated support for this crossing. The approach on the west side is currently not utilized with the approach on the east side providing access to the Village of Hines Creek sewage lagoon. The Village has indicated that access to the sewage lagoon is not usually required in winter.
- The trail will utilize the road from the highway to the sewage lagoon and then pass on the south side between the bottom of the sewage lagoon berm and the existing dugout. Some willow will be left between the trail and the dugout to direct snowmobile traffic along solid ground in this area. As the dugout is on private land and as the trail may run on or over the property line, a written agreement will be secured from the private land owner as well as the Village.
- A barb wire fence exists on the east side of the lagoon and hence the Club has requested permission from the adjoining land owner to remove a section of the fence or to install a gate. Immediately after passing through the barb wire fence, the trail turns north along the uncultivated west edge of the field in NE5-84-4-W6 before turning east at the corner where part way down the field it passes through an existing gate heading north.

Section 8

- O Upon entering SE8-84-4-W6, the trail continues north cross an abandoned residential driveway before following along the uncultivated west edge of the field. The trail crosses through the bush line at an existing opening where it then joins a portion of existing trail on the next field. The trail follows the south uncultivated edge of the field before turning north at the corner where it meets RR44. The trail then travels along the east edge running parallel to RR44.
- An existing crossing agreement is in place where the trail crosses ATCO Pipeline AER9065 line 1 in the NE corner of SE8-84-4-W6.
- About half way down the NE8-84-4-W6, the trail leaves the original trail turning east and crossing RR44 on two aligned approaches.

Section 9

Immediately after crossing the road and entering NW9-84-4-W6, the trail follows the fence line/uncultivated west edge of the field heading north and at the corner turns east along the fence line/uncultivated north edge of the field. At the NE corner of the quarter, the trail crosses TR842 where two aligned approaches exist. At this point the trail will again cross ATCO Pipeline AER9065 line 1 which will need to be added to the existing crossing agreement.

Section 16

- The trail then enters SW16-84-4-W6 and travels along the uncultivated east edge of the field. Part way down the field, the Club will place signs to indicate unmarked grave sites exist and orange marker posts to direct snowmobile traffic around the area as requested by the landowner.
- The trail will also cross the North Peace Gas Co-op Ltd. natural gas line. North
 Peace has previously advised the Club that a crossing agreement is not required.
 One Call will be utilized prior to any sign installation in this area.
- The trail will cross into the NW16-84-4-W6 briefly before turning east into NE16-84-4-W6 where it follows the uncultivated south edge of the field to the SE corner. At this point the trail will again cross ATCO Pipeline AER9065 line 1 which will need to be added to the existing crossing agreement.

Undeveloped road allowance RR43

- The trail turns north and travels along the road allowance which runs parallel to the Canfor property and P-100 road. This undeveloped road allowance will require mulching and will be laid out to avoid creating erosion to the fields to the west.
- Near the north end of the route in the portion of the undeveloped road allowance on the east side of NE16-84-4-W6, the trail encounters a large dirt pile likely created when the deep ditch next to the Canfor P-100 road was constructed, at which point the trail will briefly travel on the east side of NE16-84-4-W6 to avoid the dirt pile before turning back into the undeveloped road allowance.
- The trail continues north along the undeveloped road allowance until it intersects with the original trail where it crosses TR844. Mulching will be required up to a point just south of this crossing.
- The trail then follows the original trail on the road allowance on the east side of 28-84-4-W6 which has already been mulched.
- When the trail reaches the road allowance on the east side of SE33-84-4-W6, it
 will continue north in the undeveloped road allowance however as the existing
 trail utilized the field for access, this section of undeveloped road allowance will
 require mulching.
- The trail will then continue on the existing trail in the road allowance on the east side of NE33-84-4-W6 where it first crosses a lease road that is co-operated by Long Run Exploration and Scavenger Energy. The trail continues north on the undeveloped road allowance except for a brief excursion to the west to bypass an erosion area before crossing the Canfor P-100 road in the NE corner. The

Club has an existing agreement with the landowner for the excursion as well as the energy companies for the lease road crossing.

Stream Crossings

This alternative route eliminates three (3) crossings of Jack Creek with no new crossings required.

Other Topographical Considerations

There are only a couple of other such considerations:

- The dugout to the south of the sewage berm The intent is to pass on solid ground between the bottom of the berm and the dugout leaving a small barrier of willows between the trail and the dugout.
- RR43 undeveloped road allowance on the east side of NE16-84-4-W6
 - Erosion concerns related to mulching The plan is to lay out the route in the undeveloped road allowance to avoid creating erosion of the land to the west.
 - Large dirt pile in the north end The plan is to route the trail for a short distance across private land to bypass the dirt pile.

Overlapping Dispositions

Municipalities

- Village of Hines Creek
 - Access associated with the routing in the area of their sewage lagoon will need to be added to the existing agreement.
- Clear Hills County
 - As the County has advised that they will not provide a formal road use agreement for the use of the RR43 undeveloped road allowance, Council's support for the added mulching and use of the additional portion of the road allowance will be required. Council will also be requested to provide approval for the two new road crossings which will replace two existing crossings.

Right of Ways

- ATCO Pipelines
 - Crossing of AER 9065 line 1 in NW9-84-4-W6 will need to be added to the existing agreement.
- North Peace Gas Co-op Ltd.

 They will be advised of the new crossing in SW16-84-4-W6 and as per Club protocol One Call will be utilizing prior to the installation of any sign or marker posts.

Roads

- Alberta Transportation
 - Upon final approval by all parties, a formal crossing agreement will be completed. Alberta Transportation has indicated preliminary support for the crossing.
- County of Clear Hills
 - Two new road crossings are required on RR44 and TR842. A request is made to remove the existing signage at two crossing no longer required and to install the signage at the new crossing locations.

Private Land

- The following land owners have provided signed Letters of Support allowing the trail associated with the alternate route to access their land:

 has been advised of the alternate route.
- Trevor Kerschbaumer As the renter of the of the Manulife lands and as the owner of SE16-84-4-W6, Trevor has been advised of the alternate route.

Closing Comments

Final approval will only be considered to be in place when the support of all stakeholders is in place and once all three (3) of the primary stakeholders – Clear Hills County, Village of Hines Creek and Alberta Environment and Parks have provided their approvals. Development will not commence until Licence Agreements with land owners and all other required stakeholder agreements are executed.



- The trail would be for winter use by member snowmobiles and Club grooming equipment.
- O The trail would be 5 metres wide and would utilize the 5 metres of cultivated land next to the edge of the field to ensure minimal impact should a swathed crop be left in the field over winter. Should a standing crop be left in the field over winter, the Club would work with you and/or the renter of the land, to close the trail if required.
- o The Club will install steel sign posts with traffic type signs and orange marker posts to identify the route. These will be installed only on the uncultivated edge of the field and on the road approach. Should the Club property be damaged during agricultural

- activities, it will be the responsibility of the Club to replaces this property at our expense.
- Should there be utility right of ways associated with the land noted above, the Club acknowledges their responsibility to identify and seek support/approval for the crossings.
- o The Club will be responsible for providing liability insurance coverage for the trail through their association with the Alberta Snowmobile Association of which the Club is a member.

Subject to final approval being received and prior to commencing development work, a Licence Agreement covering your land will be provided for signing. It is anticipated that development work would take place later this year prior to the start of the winter season. The development work associated with your land is only expected to involve minor hand clearing along the uncultivated edge of the field and the installation of signage and posts.

It would be appreciated if you would indicate your support for this trail by signing and returning one copy of this letter. As Derek Meashaw is known to rent your land for agricultural purposes, Derek has been made aware of the alternate route and a copy of this letter has been sent for his information. Please do not hesitate to contact me should you have any further questions prior to or after signing this Letter of Support.

As you were made aware from the following email that was sent to you earlier in the month, our Club lost access to a significant portion of our trail on private land when the lands were purchased by Manulife who would not provide approval for continued access. As well, it was noted that work would take place to determine the potential for an alternate route, which is the purpose of this email.

Included in the land purchased by Manulife was the land between the Village of Hines Creek and the creek which the Club was using to cross under the bridge on highway 64. The major consideration in identifying an alternate potential route was how to cross highway 64 safely now they we could not access the creek/bridge. The Club has identified an alternate on which your input is requested. The alternate would see the crossing utilize existing aligned approaches. The west approach is at the corner of the Village land and the start of the Manulife land which is accessible from the current portion of approved trail we have access to. The aligned approach on the east side is used by the Village of Hines Creek for access to their sewage lagoon. We believe the lagoon access is not used during the winter months and hence a meeting is being set up with the Village later this week to discuss. As the Club is undertaking preliminary investigation, it would be appreciated if you would comment on the potential acceptability of this crossing. A rough map has been attached for your information.

Should the feasibility of an alternate route be determined, the Club will proceed to secure formal approvals as the next step including finalizing details and an agreement with Alberta Transportation. Obviously the Club is working to secure the access required so that we can have a fully function trail early in the 2019/20 season.

You may recall that the Club had contacted you to seek preliminary support for the potential of relocating our staging area from the Village of Hines Creek to km 5 on the Canfor Road to which your reply was appreciated. My email of 10APR19 advised that the Club membership had indicated support for this move of the staging area as well as support for identifying an alternate route to connect the Village. Although the identification of an alternate route was anticipated to be difficult and take a couple of years to complete, this proved to not be the case. As of late last week the Club has received preliminary indication from all stakeholders advising of support for an alternate route. Over the next couple of months the Club will be working to secure written support and final approval for this alternate route and if approval is received, the move of the staging area will not be required. I will update you once final approval is in place.

In the mean time, Debbie I have provided a marked up map showing the proposed alternate route for your information.
