# **Submitting an Appeal**

#### Appeals must be submitted on time and with the required fee

Sections 645, 678, and 686 of the *Municipal Government Act*, RSA 2000, c M-26, require that your Notice of Appeal be submitted to the Peace Regional Subdivision and Development Appeal Board (SDAB) within the legislated timeframe and with the required fee. Fees are as follows:

Type of appeal	Fee
Subdivision	\$150.00
Development	\$150.00
Stop Order issued under section 645 of the Municipal Government Act	\$150.00

**Refund:** If an appeal is withdrawn prior to the arrangement of the hearing, the fee <u>may</u> be refunded. Any request for a refund should be submitted with the appeal and should include a written statement of the reasons for the request.

## How to submit your appeal and pay your fee

Notices of Appeal must be filed with the Board in writing within the time limits set out in the MGA. You must submit your Notice of Appeal by mail or deliver it in person to the municipality which the appeal originates. Please address your Notice of Appeal to the Chief Administrative Office of the Municipality.

You can submit your Notice of Appeal by mail or deliver it in person. Regardless of how you submit your Notice of Appeal, it must be received on or before the final appeal deadline.

Please make cheques payable to your Municipality.

## What happens after my appeal is submitted?

Once your Notice of Appeal is submitted on time and with the required fee, the appeal will be heard by the SDAB within 30 days. A Clerk of the SDAB will contact you about the appeal hearing. You and the landowners who are adjacent to the property in question will receive a written Notice of Hearing.
