The Board is presented with information regarding the Provincial Government removing fusarium graminearum from the Pest Act.

#### BACKGROUND:

On June 3, 2020, The Minister of Agriculture and Forestry signed a ministerial order removing fusarium graminearum from the Pest and Nuisance Control Regulation.

In response, Northern Sunrise County is in the process of drafting a bylaw under the MGA to keep fusarium as a pest in their County. They are wanting to have a regional ASB Chairs meeting along with the Ag Fieldmen from the region to discuss the appetite for every Peace region municipality to draft a fusarium bylaw under the MGA.

Clear Hills County has never scouted for fusarium in the past. The County reimburses producers for grain samples that were sent in to be tested for fusarium.

# Helping Alberta's farmers stay competitive

The Government of Alberta is helping farmers by modernizing rules, reducing red tape and creating new research opportunities.

Seed growers in Alberta will soon have access to more seed varieties and cereal research. Minister of Agriculture and Forestry Devin Dreeshen has signed a ministerial order removing Fusarium graminearum (fusarium) from the Pest and Nuisance Control Regulation, bringing Alberta in line with best practices from other provinces.

Fusarium is a fungal disease of cereal crops that affects grain development and quality. Removing it from the regulation will allow Alberta to modernize to managing the disease, rather than having zero tolerance for it.

Regulating fusarium has failed to stop its spread, which has increased across the province over the past 20 years. The Alberta Fusarium graminearum Management Plan, published in 2002, does not account for recent advances in seed treatment options that can lower detections, bringing them close to zero.

This long-overdue change creates new opportunities for our farmers by levelling the playing field. Modernizing these rules means that Alberta farmers will benefit from current research advances."

## BYLAW NO. BXXX/XX

# BEING A BYLAW OF "MUNICIPALITY" IN THE PROVINCE OF ALBERTA TO MINIMIZE THE ADVERSE EFFECTS OF PROHIBITED AND NOXIOUS SPECIES WITHIN "MUNICIPALITY"

**WHEREAS**, pursuant to the *Municipal Government Act*, R.S.A. 2000, c. M-26, as amended, the Council of "Municipality" may pass bylaws for municipal purposes;

**AND WHEREAS** the presence of prohibited and Noxious Species in "Municipality" threatens the economic well-being and viability of the agricultural producers in the Municipality;

AND WHEREAS "Municipality" has deemed it expedient and in the public interest to restrict the spread of prohibited and Noxious Species within the Municipality;

**NOW THEREFORE**, the Council of "Municipality", in the Province of Alberta, duly assembled, hereby enacts as follows:

#### 1. TITLE

1.1. This Bylaw shall be known as the "Prohibited and Noxious Species Bylaw".

#### 2. DEFINITIONS

- 2.1. In this Bylaw:
  - 2.1.1. "Acts" means the Agricultural Pests Act (R.S.A. 2000, Chapter A-8) and the Weed Control Act (S.A. 2008, Chapter W-5.1) including any amendments or successor legislation thereto.
  - 2.1.2. "Control" means to inhibit the growth or spread, or to Destroy.
  - 2.1.3. "Council" means the Council of "Municipality".
  - 2.1.4. "Municipality" means "Municipality".
  - 2.1.5. "Destroy" means to kill all growing parts, or to render reproductive mechanisms non-viable.
  - 2.1.6. "Inspector" means a person appointed as a municipal Inspector for Prohibited Species and Noxious Species under this bylaw and/or under the *Agricultural Pests Act* or the *Weed Control Act*.
  - 2.1.7. "Land" includes
    - 2.1.7.1. fixtures on the Land, and
    - 2.1.7.2. the Land down to the low water mark of a stream, lake or other body of water that borders or is located on Land.

- 2.1.8. "Livestock" means cattle, sheep, domestic cervids within the meaning of the *Livestock Industry Diversification Act*, goats and other captive ruminants, swine, horses and poultry.
- 2.1.9. "Noxious Species" means a Pest/Weed, designated, and includes the plant's seeds, animal offspring, and disease pathogen.
- 2.1.10. "Occupant" means a person occupying or exercising control or having the right to occupy or exercise control over Land or Property.
- 2.1.11. "Owner" means
  - 2.1.11.1. in respect of Land, the person who is registered as an Owner of the Land under the *Land Titles Act*, or
  - 2.1.11.2. in respect of personal Property or Livestock, the person who
    - 2.1.11.2.1. is the legal Owner of it,
    - 2.1.11.2.2. has lawful possession of it, or
    - 2.1.11.2.3. has the right to exercise control over it.
- 2.1.12. "Prohibited Species" means a Pest/Weed, including plant, animal or disease pathogen designated as a prohibited Noxious Species and includes the plant's seeds, a live animal, and disease pathogen.
- 2.1.13. "Property" means personal Property, includes Land, crops, material, structures, and vegetation excluding Livestock.
- 2.1.14. "Pest/Weed" means an animal, bird, insect, plant or disease declared to be a Prohibited Species or a Noxious Species under sections 25 and 26.
- 2.1.15. "Seed-cleaning Facility" means a building, structure or vehicle that is designed, intended or used to clean, grade or size seed.

#### PART 1 WEED AND PEST CONTROL

#### 3. DUTY OF AN OCCUPANT/OWNER

- 3.1. Noxious Species Control
  - 3.1.1. An Owner or Occupant of Land or Property or the Owner or person in control of Livestock shall take active measures to
    - 3.1.1.1. prevent the establishment of Pest/Weed on or in the Land, Property or Livestock unless otherwise authorized by Council,
    - 3.1.1.2. Control or Destroy all Pest/Weed on or in the Land, Property or Livestock unless otherwise authorized by the Council, and
    - 3.1.1.3. Destroy any crop, vegetation or other matter that contributes or may contribute to the maintenance or spread of a Pest on or in the Land, Property or Livestock.
- 3.2. Prohibited Species Destroy
  - 3.2.1. A person shall Destroy a Prohibited Species that is on Land, Property or Livestock the person owns or occupies.

- 3.3. A person shall not import, purchase, sell or otherwise dispose of, transport, distribute or plant any infestable item that is infested or any Pest without the prior written authorization to do so of an Inspector.
- 3.4. If an infestable item that is or is suspected to be or that subsequently transpires to be infested, or a Pest, is or was imported, purchased, sold or otherwise disposed of, transported, distributed or planted, each person involved in that activity shall provide to an Inspector, on request, the names and addresses of all other persons known to be so involved, within 24 hours of the request or within such longer period as is specified by the Inspector.
- 3.5. To facilitate the identification of Livestock to help prevent the spread of an infestation, an Inspector may attach a Pest infestation tag to the Livestock or Property.
- 3.6. A person shall not remove or have removed an Inspector's notice or a Pest infestation tag attached under subsection 3.5 until
  - 3.6.1. authorized to do so by an Inspector, or
  - 3.6.2. in the case of cattle, the cattle have been sold at and removed from a market.
- 3.7. A person shall not sell or otherwise dispose of, purchase, transport, distribute or plant anything detained under subsection 3.6 before it is released under subsection 3.8
- 3.8. An Inspector may release the Property detained under subsection 3.5 by providing a written notice of release of it in the form set out in Schedule A.

#### 4. SPREAD OF SPECIES PROHIBITED

- 4.1. Subject to the regulations, a person shall not use or move any Property or Livestock that, if used or moved, might spread a Noxious Species or Prohibited Species.
- 4.2. Subsection 4.1 does not apply if the thing is used or moved in a manner directed by an Inspector under section 12.

#### 5. DISPOSAL AND STORAGE OF WEED SEEDS

- 5.1. A person shall not deposit or permit to be deposited noxious Weed seeds or prohibited noxious Weed seeds where they might spread.
- 5.2. A person shall store refuse that may contain Noxious Species seeds or Prohibited Species seeds, including screenings from cleaning, sizing or grading seed, in a container that will prevent the scattering of the seeds.
- 5.3. Subsection 5.2 does not apply if the refuse is disposed of in a manner directed by an Inspector under section 12.

#### 6. SEED-CLEANING FACILITY

- 6.1. A person shall not operate a Seed-cleaning Facility or provide a Seed-cleaning Facility for rent or lease
  - 6.1.1. unless the person is licensed under the respective *Act*, *Regulations*, and/or this Bylaw, and
  - 6.1.2. except in accordance with the terms of the license.
- 6.2. Despite subsection 6.1, a farmer may operate a Seed-cleaning Facility the farmer owns to process seed for the farmer's personal use.

#### PART 2 INSPECTORS

#### 7. INSPECTORS

7.1. The Municipality shall appoint Inspectors for this Bylaw and/or the *Acts*, to enforce and monitor compliance with this Bylaw, and the respective provincial *Acts* within the Municipality.

#### 8. INSPECTORS – JOINT AUTHORITY

8.1. An Inspector appointed by the Municipality may, with the consent of another municipality, enforce and monitor compliance with this Bylaw within the other municipality.

#### 9. INSPECTOR'S IDENTIFICATION

- 9.1. A person who appoints an Inspector shall provide the Inspector with identification in the form required by the Municipality and/or the respective *Acts*.
- 9.2. An Inspector identification for the *Acts* shall be deemed valid for identification for this Bylaw.
- 9.3. An Inspector shall, on request, produce the Inspector's identification while acting under the authority of this Bylaw, and/or the respective *Acts*,
  - 9.3.1. in respect of Land, to the Occupant or Owner of the Land, and
  - 9.3.2. in respect of personal Property, to the Owner of the personal Property.

# PART 3 INSPECTOR POWERS AND NOTICES

#### 10. OBSTRUCTION OF INSPECTOR

10.1.A person shall not willfully obstruct or delay an Inspector in the exercise of the Inspector's duties or powers to enforce and monitor compliance with this Bylaw.

#### 11. ENTRY AND INSPECTION POWER

- 11.1. An Inspector may enter Land or inspect Land or personal Property at a reasonable time
  - 11.1.1. to monitor compliance with this Bylaw and the respective *Acts*, including making inquiries, taking samples, or performing tests, or
  - 11.1.2. to enforce an Inspector's notice, in accordance with section 15.
- 11.2. An Inspector shall not enter a building unless the Owner or Occupant of the Land on which the building is situated
  - 11.2.1. consents, or
  - 11.2.2. has been given a written notice.
- 11.3. Subsection 11.2 does not apply if the building is, or is part of, a Seed-cleaning Facility, grain-handling facility or auction market.
- 11.4. An Inspector shall not enter a private residence unless the Occupant of the Land consents.
- 11.5.A written notice under subsection 11.2.2 must name a reasonable time of entry and be given at least 24 hours before the time of entry.

11.6.An Inspector who finds on any premises evidence of an infestation on the Property or the Livestock may notify persons engaged in the growing, transporting or processing of any Property or Livestock that may be affected by the infestation, or any organizations representing them, of the infestation, including the location of those premises and the name of their Occupants, if the Inspector considers such notification necessary or advisable with a view to preventing the spread of or Controlling the infestation.

#### 12. INSPECTOR'S NOTICE

- 12.1.If an Inspector finds non-compliance with this Bylaw, an Inspector may give an Inspector's notice in writing requiring compliance
  - 12.1.1. in respect of Land, to the Occupant of the Land and to the Owner of the Land, and
  - 12.1.2. in respect of personal Property, to the Owner of the personal Property.
- 12.2.If an Inspector finds Prohibited Species that have not been Destroyed, the Inspector shall give an Inspector's notice requiring the Prohibited Species to be Destroyed or as per the respective policy.

#### 13. SUBSEQUENT OWNER OR OCCUPANT SUBJECT TO NOTICE

- 13.1.A notice given under this Bylaw is effective against a subsequent Owner or Occupant of the Land or a subsequent Owner of personal Property from the time the notice was originally given.
- 13.2. An Owner of Land or personal Property shall provide a copy of the notice to a person before that person enters into an agreement to acquire the interest in the Land or personal Property.
- 13.3.A Chief Administrative Officer shall, on request, provide a mortgagee or purchaser of Land a copy of all active notices given under this Bylaw and/or *Acts* that relate to that Land.

#### 14. CONTENTS OF INSPECTOR'S NOTICE

- 14.1. An Inspector's notice must direct the method, subject to the policies, and time for compliance with this Bylaw.
- 14.2. The notice may contain directions, including limiting the use of Land, for the year in which it is given and the following year.
- 14.3. The notice must not require the destruction of crops unless in the Inspector's opinion the destruction of crops is necessary to Control Noxious Weeds, Destroy Prohibited Noxious Weeds, or to Control or Destroy Pest.
- 14.4. The notice may require the destruction of 160 acres of growing crops as per respective policy.
- 14.5. Subsection 14.4 does not apply if the growing crop
  - 14.5.1. does not have a significant commercial value, or
  - 14.5.2. is a crop of Noxious Species or Prohibited Species.

#### 15. COMPLIANCE WITH NOTICE

- 15.1.A person given a notice under this Bylaw in accordance shall, subject to the right to appeal a notice, comply with the notice.
- 15.2. If a notice of appeal is filed, a notice is stayed until the appeal is disposed of.

#### 16. ENFORCEMENT OF NOTICE

- 16.1. An Inspector, or any person authorized by an Inspector, may take any action that the Inspector determines is necessary to fulfil a requirement of a notice given under this Bylaw that has not been complied with when in respect of an Inspector's notice
  - 16.1.1. the appeal period in the regulations has expired or the appeal has been determined, and
  - 16.1.2. the request for review period in the Bylaw has expired or the request has been considered.

#### 17. REMEDIAL MEASURES

- 17.1. Where an Owner does not comply with a notice within the period specified in the notice, an Inspector or a person authorized by an Inspector may
  - 17.1.1. enter onto the Land specified in the notice, and
  - 17.1.2. carry out the remedial measures set out in the notice.
- 17.2. Subject to section 21.1, where the payment of the expenses demanded under subsection 21.2 is not made within the 30-day period, the local authority may do one or both of the following
  - 17.2.1. add the unpaid expenses to the tax roll as an additional tax against the Land in respect of which the expenses were incurred;
  - 17.2.2. recover the unpaid expenses as a debt due to the local authority by action against the Landholder and, if the Landholder is not the Owner, the Owner.

#### 18. SERVICE OF A NOTICE

- 18.1.A notice given under Part 3 must
  - 18.1.1. be in the form required by this Bylaw, and/or applicable Acts
  - 18.1.2. be served on a person in accordance with subsection 18.2 or 18.3.
- 18.2. The notice must be served on a person
  - 18.2.1.1. by posting the notice
    - 18.2.1.1.1. on the land or, if practicable, on the personal Property to which the notice relates, or
    - 18.2.1.1.2. at the private residence of the person intended to be served, and
  - 18.2.1.2. by sending a copy of the notice by certified mail
    - 18.2.1.2.1. in respect of Land, to the last address listed in the assessment roll of the Municipality for the Owner of the Land, or
    - 18.2.1.2.2. in respect of personal Property, to the last known address of the Owner.
- 18.3. For this section, a notice sent by certified mail is deemed to have been received by the person 7 days from the date of mailing.

#### PART 4 APPEAL OF A NOTICE

#### 19. APPEAL OF AN INSPECTOR'S NOTICE AND DEBT RECOVERY NOTICE

- 19.1. The Municipality shall appoint members annually to an independent appeal panel to determine appeals of Inspector's notices, and debt recovery notices.
- 19.2. A person who is given an Inspector's notice, or debt recovery notice may, in accordance with the regulations or the Bylaw, appeal it to an appeal panel.
- 19.3. The appeal panel may confirm, rescind, or vary the Inspector's notice, or debt recovery notice.
- 19.4. Within 5 days after receipt of a notice of appeal, the committee shall hear and determine the appeal and the committee may confirm, rescind or vary the notice that was issued.
- 19.5. The municipal clerk shall, on determination of the appeal, send a copy of the decision together with the written reasons, if any, by certified mail to the appellant.

#### 20. APPEAL PROCESS

- 20.1.A person who
  - 20.1.1. has an interest in Land as an Owner or Occupant, or
  - 20.1.2. has an interest in Livestock as an Owner or person in control of Livestock

and feels personally aggrieved by a notice issued by an Inspector under section 12 may appeal to the Municipality within which the Land or Livestock is located by filing a notice of appeal under this section.

- 20.2.A notice of appeal shall be in writing and shall set out
  - 20.2.1. the name and address of the appellant,
  - 20.2.2. a copy of the notice in respect of which the appeal is being taken,
  - 20.2.3. the legal description of the Land affected or a description of the Livestock affected and the legal description of the Land on which the Livestock were located, and
  - 20.2.4. the grounds for appeal.
- 20.3.A notice of appeal shall be served on the municipal secretary
  - 20.3.1. by any of the methods set out in section 18, and
  - 20.3.2. within the time specified in the notice issued under section 12 for taking any measure, or within 10 days after service of the notice, whichever is less.
- 20.4. A notice of appeal shall be accompanied with a deposit in an amount of \$500 which shall be refunded if the appellant is successful in the appellant's appeal under this section.

# PART 5 RECOVERY OF INSPECTOR'S EXPENSES

#### 21. DEBT RECOVERY NOTICES

- 21.1.Expenses incurred by an Inspector enforcing an Inspector's notice are a debt due to the Municipality by the person subject to that notice.
- 21.2. The Chief Administrative Officer, or any person authorized by the Chief Administrative Officer, shall give a debt recovery notice to the debtor

- 21.2.1. demanding recovery of the debt due, including a statement of expenses, and
- 21.2.2. advising of the debtor's right to appeal the debt recovery notice.
- 21.3. The Municipality may recover the debt due in accordance with subsection 21.4 from any person who is given a debt recovery notice if
  - 21.3.1. the person has agreed in writing to repay the debt due,
  - 21.3.2. the person's rights of appeal and review of the debt recovery notice under sections 19 and 20 have expired, or
  - 21.3.3. the appeal and review of the debt recovery notice have been determined.
- 21.4. The Municipality may recover the debt due from any person who is given a debt recovery notice in either or both of the following manners:
  - 21.4.1. in the same manner as Property taxes against Land to which the Inspector's notice relates;
  - 21.4.2. by filing a certificate with the clerk of the Court of Queen's Bench at any judicial centre certifying the amount owing.
- 21.5.A certificate filed under subsection 21.4.2 becomes an order of the Court of Queen's Bench and may be enforced as a judgment of that Court.

#### PART 6 MISCELLANEOUS MATTERS

#### 22. OFFENCE AND PENALTY

22.1.A person who contravenes this Bylaw and/or the *Acts* is guilty of an offence and liable to a fine of not more than \$10,000 and \$5000 respectively as per Section 566 of the *Municipal Government Act*, R.S.A. 2000, c. M-26.

#### 23. DISPOSITION OF FINES

23.1.A fine imposed for an offence under this Bylaw committed within the Municipality belongs to the Municipality as per Section 566 of the Municipal Government Act, R.S.A. 2000, c. M-26.

#### 24. POLICIES

- 24.1. The Council may make policies and other bylaws
  - 24.1.1. respecting the designating of an invasive plant, animal or disease as a Noxious Species or Prohibited Species, generally or in respect of any part of the Municipality;
  - 24.1.2. respecting the directions that may be given in a policy;
  - 24.1.3. respecting the sale, use, handling or movement of a thing that might contain or cause the growth or spread of Noxious Species or Prohibited Species;
  - 24.1.4. respecting appeals, appeal panels and reviews of appeals;
  - 24.1.5. respecting the licensing of a person who operates a Seed-cleaning Facility or who provides a Seed-cleaning Facility for rent or lease;
  - 24.1.6. respecting forms for the purposes of this Bylaw.

#### 25. PROHIBITED SPECIES

- 25.1. Weeds listed in Policy 2.7 Schedule A, Part I referred to as Prohibited Noxious Weeds and those elevated through municipal bylaw.
- 25.2. Glyphosate Tolerant Alfalfa
- 25.3. Following Animals, Insects, Birds
  - 25.3.1. Africanized bees
  - 25.3.2. Norway Rat
  - 25.3.3. Warble fly Hypoderma
  - 25.3.4. Wild boar when at large
- 25.4. Following Diseases
  - 25.4.1. Clubroot Plasmodiophora brassicae
  - 25.4.2. Fusarium head blight Fusarium graminearum
  - 25.4.3. Rabies Rhabdoviruses

#### **26. NOXIOUS SPECIES**

- 26.1. Weeds listed in Policy 2.7 Schedule A, Part II referred to as Noxious Weeds
- 26.2. Following Animals, Insects, Birds
  - 26.2.1. Columbia River root knot nematode Meloidogyne chitwoodi

28.1.Upon third reading of Bylaw B379/20, Bylaw B341/18 Glyphosate Tolerant Alfalfa and all amendments thereto are repealed.





#### **OTHER TOPICS**

- 1. Weed and Pest inspections are business as usual, weather permitting. We have appointed 3 weed/pest inspectors this summer Crystal Dei, Cindy Campbell and Roxanne Lefebvre.
  - a. There have been two prohibited noxious weeds found in the county, both on road sides orange hawkweed (2 plants) and sulphur cinquefoil (several plants). All the plants found have been destroyed and survey for more continues.
  - b. Weed and Pest Inspector training has all been delivered online this year. Presenters recorded their training sessions and posted them to youtube.
- 2. Road side spraying is being restricted to road shoulders due to the wet conditions in the ditches. These wet conditions have also halted the roadside mowing program for the foreseeable future.
  - a. Wet conditions across the County vary from near normal to wettest in over 50 years.
- 3. Pesticide Applicator's are able to take all credits through online courses, this change is currently effective until end of March 2021.
- 4. Large livestock evacuation planning this is being led by the M.D. of Peace and they are seeking that the initial meetings to start work on this emergency risk mitigation plan be held post COVID or as early as the late fall or early winter of 2020/2021.
- 5. Zero Till Drills sold for \$23,000 (original purchase price was \$57,700 in 2011).
- 6. Rental equipment use has been steady.
  - a. There have been modified procedures put in place due to the COVID-19 requirements for sterilization and physical distancing from renters.
  - b. All rental equipment inquiries, bookings, pickups and returns are dealt with through the Agricultural Fieldman Greg Coon. ALL rental equipment pick ups and returns need to be done by appointment time only.
- 7. No new reports of clubroot since last year. The closest to our municipality was a positive test in MD of Peace in 2018 in a field closer to the Peace River airport. Testing has been done in that field last year and no positive tests have come back, however, the landowner is under a pest enforcement notice to not grow canola for 4 years. The only other positive tests in the Peace region was a 2018 positive test in Saddle Hills County and a 2019 one in County of Grande Prairie.
- 8. The Agricultural Service Board Legislative Stream Grant will be cut by 27% from last years amount. For Clear Hills County, this represents a reduction of \$45,457.05 in funding for 2020.

#### **Big Lakes County Declares Agricultural Disaster**

**July 15, 2020:** Big Lakes County Council declared a Municipal Agricultural Disaster at the June 24, 2020, Council Meeting.

In 2019, agricultural producers faced a year of continuing challenges, with a very wet fall and an early snowfall causing pockets of the County to remain unharvested. In the spring of 2020, the County saw above-average moisture conditions, severely impacting producers' ability to seed crops and harvest remaining crops from 2019.

"This past year, local producers have had an increasingly difficult and stressful harvest and spring seeding, which has caused many hardships, both financially and mentally," said Big Lakes County Agricultural Advisory Committee Chair Doug Meneice. "With approximately 40 percent of the land seeded in our County, and with the recent precipitation and flooding, we anticipate a challenging 2020 harvest. With the unexpected precipitation in 2019 and 2020, many hay producers will also be affected in attempts to bale quality hay to raise livestock through the winter months. Anticipating a shortage of cereal crops as well as quality hay will again put extreme financial hardship on beef producers."

Currently, thousands of acres remain unseeded throughout the County. Producers who were fortunate enough to seed successfully have struggled with adverse growing conditions brought about by the cool, wet weather and have not been able to access fields to apply crop protection.

"Our agriculture industry has faced several challenges in the past five years, leaving our producers financially in need of a good growing season and strong cattle prices," said Big Lakes County Reeve Richard Simard. "2020 instead handed them Covid-19 and poor seeding and growing conditions. While Business Risk Management products are available to bridge bad seasons, the compounded impact of multiple years of terrible conditions has left Council deeply concerned for the future of agriculture within Big Lakes County and Alberta without additional support."

Through the declaration of a Municipal Agricultural Disaster, Big Lakes County Council hopes that the Government of Alberta considers supporting our producers in the form of increased financial aid and increased access to mental health recourses. In doing so, the County hopes to ensure the continued viability of the agricultural sector in our area and Alberta.

"In Big Lakes County it is predominantly Agriculture that we rely upon economically, with many producers depending upon that industry to live and to raise their families,"

## On July 8<sup>th</sup>, 2020, Council for the Municipal District of Smoky River No. 130 declared a state of agricultural disaster

Due to persistent, excessive precipitation that hampered the harvest of crops remaining from 2019, prevented a significant number of acres from being seeded and has now caused crop death and stress to seeded crops, the M.D. of Smoky River declared a state of agricultural disaster at the regular Council meeting held July 8<sup>th</sup>.

The M.D. joins several Alberta municipalities in this declaration, notably a neighboring Peace Region municipality, Big Lakes County as well as several others including Lac La Biche County, Smoky Lake County, Athabasca County, Lamont County, and Thorhild County in taking this action.

With this declaration, Council hopes to bring to the Provincial and Federal Governments attention the extremely serious financial and psychological stresses being incurred by the municipality's agricultural producers. These severe hardships began with the saturated field conditions experienced during the 2019 harvest, which continued into the spring of 2020, were exacerbated by poor commodity prices and other Covid-19 induced issues and are culminating with the current excessive moisture in crops dying or being severely stressed.

Council, on behalf of all M.D. agricultural producers ask that the Provincial and Federal Governments fast track their review of the Business Risk Management programs and make much needed improvements to the AgriStability program and to proceed with assistance under AgriRecovery.

#### Re: State of Agriculture Disaster

This letter brings attention that the County of Northern Lights has declared an Agriculture Disaster following the motion made the 14<sup>th</sup> day of July 2020.

As mentioned above the County of Northern Lights is experiencing harsher than average agricultural conditions. Our area has seen unprecedented rainfall as of late. These difficult conditions are compounded by the horrific year experienced in 2019 due to excessive late summer and fall moisture. Economic hardship fell on many producers as they struggled to make ends meet resulting from lower yields, poor quality, lack of feed and damaged fields for the next year.

As most producers looked optimistically to a better 2020, they were met with wet, rough field conditions as they struggled to harvest last year's crop and seed this year's crop. At the time of this letter producers' find themselves in a familiar spot as last; drowned out crops, fields to wet to access, and the endless feeling of despair. Our municipality tried to initiate change through a 2019 agriculture disaster declaration, 4 provincial resolutions and a letter campaign to have both the Honourable Marie-Claude Bibeau and the Honourable Devin Dreeshen initiate an assessment under AgriRecovery. We were met with support at the federal level to have the Minister at the provincial level initiate a request for assessment under AgriRecovery; however, we are disappointed that Minister Dreeshen never initiated our request from a January 16<sup>th</sup>, 2020 letter to do so.

At this time, the County of Northern Lights would request Minister Dreeshen rectify and initiate the risk assessment under AgriRecovery for the 2019 calendar year, as well as extending into this current 2020 year.

We would also like the Minister to familiarize himself with the resolutions submitted at the 2020 Provincial Agricultural Service Board Conference, and work with Minister Marie-Claude Bibeau to drive change to our current business risk management. Our municipality is currently facing hardship brought on by excessive moisture, but the agriculture industry is also facing adversity. Adversities such as the current pandemic, trade wars, poor relationships with our largest buyers resulting in poor commodity prices, rising costs of production, poor risk management solutions and a lack of leadership at the provincial and federal level are all compounding the back to back hardships our producers are facing.

Undoubtedly, the County of Northern Lights agricultural producers are experiencing difficulties maintaining their livelihoods—it is about time we have our federal and provincial leadership corroborate to develop a plan for Agriculture for the foreseeable future.

We hope you do not find this letter too critical, but rather a compass in the right direction of change to bring security to this industry. We would be pleased to meet with you or any of your staff to further discuss the issues regarding our agricultural disaster.
