



#### Are you aware of the VSI (Veterinarian Services Incorporated) Program?

- \* Aids in the development of livestock expansion with a long term goal of the producer and veterinarian services sustainability.
- \* The VSI program supplies a cost-share support to livestock producers, whereby Clear Hills County covers 50% of the cost eligible veterinary procedures.
- \* Membership is \$52.50 for a five year term.

#### Do you know the County has a BSE Testing Incentive Program?

The BSE testing program is to encourage producers to participate in BST Testing and assist in realizing the target of 30,000 beef cattle annually being tested to keep Canada's status as a controlled BSE risk country.

Eligibility: must be a VSI member and resident/landowner in Clear Hills County with livestock.

Restrictions: Only Veterinarian Clinics (and livestock owners) will have access to the BSE test results.

Process: VSI services provides the County with a list of members that had beef cattle tested in the quarterly report. The County then pays the member. The 20022/2023 incentive is \$125/animal.

# **Cold & Inclement** Weather

#### SCHOOL BUS INFORMATION

The Transportation Services Manager may cancel buses either individually or collectively when weather/road conditions constitute a safety risk to the students being transported, this includes all scheduled Field Trips.

If extreme weather conditions arise after the students have been delivered to their schools, the Transportation Services Manager may authorize bus drivers to pick up students early and deliver them home. The Principal will notify parents and not allow any elementary students on the bus if the parents have not been contacted.

If it is unsafe for buses to be on the road the Principal will advise parents of the situation and hold students at the school until picked up by a parent.

Buses will not operate in the morning when the temperature at 6AM is -35°C (without windchill) OR -45'c with wind chill or lower at Key Weather Station Locations. The decision for the PM portion of the route will be decided using the same criteria as the AM.

Should cancellation of bus services occur, the Transportation Manager or designate shall post announcements of bus cancellations on Bus Planner. Each bus driver shall notify their route parents of bus service cancellation.
